#### 1.3. Conformance


This document is intended for individuals who will benefit from the Modo visual identity for any purpose. Since Modo logo is presented in various vector formats, audience is assumed to have basic knowledge of vector processing applications of any kind.

# 2. Dimensions


Since Modo logo is presented in vector format, it can be used in various sizes. However, any use of Modo logo cannot be sized smaller than the minimum width and height, which are mentioned below. One must also apply the proportional relations between the width, height and clear space of Modo logo.

Proportional relations between the width, height and clear space of Modo logo are as follows:



**Note**: The width of logo is 4.7 times its height. The clear space padding the logo is 0.3 times its height.

Warning: Minimum dimensions allowed are 94 x 20 pixels, 24.8 x 5.3 millimeters or 1.25 x 0.27 inches.

Full color usage of Modo logo is as follows:





Single color usage of Modo logo is as follows:






No-color usage of Modo logo is as follows:



### 4.4. Usage on light background


Full color usage, single color usage or no-color usage must be applied when using Modo logo over light backgrounds.





# 4.5. Usage on dark background

No-color (white) usage must be applied when using Modo logo over dark backgrounds.






Any modifications to Modo logo that are not addressed in "variations" chapter are considered misuse. Some of the misuses are as follows:

#### 5.1. Misuse of dimensions


Please do not modify the proportional relations between width and height of the Modo logo.
